- Price Basis:** The quoted rate should be inclusive of taxes, transportation charges incurred until the delivery of items to various sites under ERCMPU Ltd. unloading charges etc. No any incidental expenses will be allowed.
- Eligibility:**
 - Bidder should have sufficient experience in the relevant field (Copy of purchase orders/Work completion certificate/GST invoices).
 - The Bidder should hold registration under GST.
- Art Work:** Artwork should be approved by the Marketing Head before commencing the work.
- Delivery:** The item shall be delivered on door delivery basis including unloading charges to our units within 20 days from the date of order. The material shall be packed with securely standard moisture proof pack. The goods dispatched under the contract on FOR destination basis shall be fully insured against loss or damage in transit at Supplier's A/c.
- Payment:** 100% payment will be made from concerned dairies within 15 days after successful completion of supply, on submission of original invoice and recommendation from concerned department.
- Guarantee:** The Supplier shall have to guarantee the quality of goods supplied strictly as per specification of contract/purchase order for a period of 1 year.

8. **Liquidated Damages:**

If the supplier fails to deliver the goods within the time period specified in the contract, ERCMPU shall without prejudice to its other reminders under the contract, deduct from the price, as liquidated damages, a sum equivalent to

- a. 0.5 % of the product value for each week of delay. The total amount so deducted shall not exceed 5 % of the product value, once the maximum is reached, we may consider the termination of contract.
- b. Any incidental taxes and levies on account of delay in performance of the contract by the supplier shall be at his account.
- c. Any defective material shall have to be replaced by the supplier immediately at his own cost.
- d. However genuine reasons if any will be given due consideration, on production of documentary evidence before operating the liquidated damages clause.

9. **Validity:** Validity of the quotation should be for a period of 6 months from the date of opening the quotation.
